


# **Answers to Your Top K-12 Stimulus Fund FAQs**

#### What stimulus funds are available for K-12 education?

The CARES, CRRSA, and ARP Acts directed billions of dollars to the Education Stabilization Fund, which then splits into three primary funds:

- The Elementary and Secondary School Relief (ESSER) Fund: Allocated to State Education Agencies (SEAs), who then award at least 90% to Local Education Agencies (LEAs)/districts (87.5% in the APR Act).
- The Governor's Emergency Education Relief (GEER) Fund: Awarded at the Governor's discretion to address the highest priority needs across K-12 and public higher education institutions
- The Higher Education Emergency Relief (HEER) Fund



#### How much stimulus funding is my district receiving?

Each district will receive a different amount based upon multiple factors. The US Department of Education has launched this site that shows CARES Act allocations for states and districts (be sure to select ESSER). And here is an interactive table that shows estimated ESSER funds by state and district from the CRRSAAct.

#### Why do some districts receive more stimulus funds than others?

ESSER funds are awarded based upon the federal Title I, Part A funding formula. This makes funding distribution more equitable, yet not equal.

#### What should my district spend its funds on?

That depends upon your district's unique needs and goals. However, the legislation is intended for emergency relief. At a high level, this means activities that support the safe reopening of schools, advance equity, and accelerate student achievement. Notably, the CARES, CRRSA, and ARP Acts permit, among other things, any activity authorized by the Elementary and Secondary Education Act (ESEA) of 1965 and the Individuals with Disabilities Education Act (IDEA), which include programs related to effective teaching and learning. Due to the extended impact of the pandemic on teaching and learning in most areas, there is widespread agreement that funds should be targeted toward implementing comprehensive assessment systems with high-quality standards and skills-based content, and building data systems that empower educators to make targeted instructional decisions. Many districts are also prioritizing educator professional learning and adopting systems to support student social-emotional wellbeing.

## When do stimulus funds have to be spent?

Spending deadlines for ESSER funds were recently updated.

- CARES Act ESSER funds must be obligated by September 2022
- CRRSA Act ESSER funds must be obligated by September 2023
- ARP Act ESSER funds must be obligated by September 2023

ESSER funds may be applied to purchases made prior to the actual award of funding (but since the onset of the COVID-19 pandemic).

### What are some ways to maximize stimulus funding?

While the stimulus provides many districts with a substantial amount of new funding, the challenges they face are greater than ever. Moreover, tight spending deadlines mean districts have to think and act quickly. To get the most out of this unique one-time funding, we recommend districts:
